



DASH Patent Portfolio License Briefing*

Objective

- Offer an alternative license for the convenience of users enabling them to acquire patent rights necessary for the DASH Standard (see slide 3) from multiple patent holders in a single transaction as an alternative to negotiating separate licenses

Coverage

- Worldwide coverage (including essential counterparts)
- Licensors include all essential patents

License Grants and Royalties

- **DASH Clients (products capable of parsing a Media Presentation Description or using the parsing from a Media Presentation Description to access and/or play a DASH Segment)**
 - 0 - 100,000 units/year = no royalty (available to one Legal Entity in an affiliated group)
 - US \$0.05 per unit after first 100,000 units each year
- **Related Terms**
 - Maximum annual royalty payable by an Enterprise (Legal Entity and Affiliates) is \$0 for 2015 and 2016, \$2.5M for 2017 and 2018, and \$5M for 2019 through 2022
 - Royalties payable for products from January 1, 2017 forward
 - Includes right to make, use and sell

Term

- **Current Term through December 31, 2022**
- **Renewable for successive 5-year periods for the life of any Portfolio patent on reasonable terms and conditions**
- **Rate Protection on Renewal – royalties for specific royalty products and license grants will not increase by more than 20% at each renewal**

Other Important Provisions

- **Most Favorable royalty rates clause**
- **Licensee data is protected as confidential**
- **Grant-back on essential patents similar in scope to license grants**
